Before discussing the motion does anyone know of anything scheduled to be held locally which might clash with our music/markets if we decide to go ahead with Friday December 6.

Also Libby could you please update the committee about whether there is anything going on for that date via your council inquiries, as per our discussion earlier in the week.

Provided we don't know of any event with which we might clash please consider the motion.

#### **MOTION**

The P&C agree to book Brad Haling for two hours, at a cost of \$100 an hour, for Friday December 6. If we could let Mr Haling know that the time of the performance will be decided at our next full meeting scheduled for Thursday June 25. We can confirm a time with him after that. This will give our committee time to plan the event and take into consideration other factors which require time considerations.

It is proposed to charge a gold coin donation (kids and adults) with this money to go towards the cost of Mr Haling. Additionally we will charge stalls \$15 to attend. This money could also be used to offset the music cost. Additionally a P&C barbecue and stall(s) are other avenues to pay for the music cost as required.

Can members also agree – considering we do not have a lot of meetings - that should something arise in relation to this event, which needs a quick decision it can be discussed by the president with members via the Messenger group, and decisions made.
