<b>Travel</b>	Players are responsible for their own transport to and from the trials.
<b>Clothing &amp; Equipment Required</b>	Players are to wear appropriate clothing (preferably with a number – see your school sport coordinator) and footwear to participate in the trial. Players should bring a water bottle and can choose to bring their own ball (not required).

#### Additional Information-

- The Western trials for this sport will be held on **Friday 8<sup>th</sup> March in Bathurst**.
  - Do not nominate/attend the Dubbo District trials if your child is unavailable for selection for WSSA or NSW PSSA trials later in the year.
  - Please note: If your child is selected and does not attend the regional trial without a good reason your child may become ineligible for further district selections during the next year.
- Conditions of trialling-
  - **Students MUST have a note that has been signed by their Principal and parent/carer otherwise they are not eligible to trial**
  - Students should preferably be in Stage 3 (Year 5/6), however if a student demonstrates excellence in a certain sport and they are in Year 4, they may be nominated by individual schools.
- In the case of inclement weather conditions, the convenor consults the President as to whether the trials will go ahead. A decision will be made by the convenor and President and schools will be notified by email no later than 2pm on the day of the trial.
- Where students cannot attend a DDPSSA trial due to extenuating circumstances, their own school **MUST** complete the Exemption Form and email through to the President & Secretary prior to the trial.
  - Extenuating Circumstances DO NOT include illness, family holidays, clash of other school commitments or failure to receive information from your school. Normal selection procedures leading up to District trials **MUST** be attended / followed.
  - Receipt of this form allows students to be **considered** for a Dubbo District team – it does not guarantee team selection. Medical clearances must be provided for injury or illness.
- Team Selection Criteria- a student may be selected for a team if they display the following-
  - Technical ability and tactical skills for the particular sport
  - Positional play and understanding
  - Fitness and athletic ability
  - Team play and court/field/pitch strategies
  - Understanding of the game and rules
  - Positive sportsmanship at **all** times and an active member of a team
- Successful & Unsuccessful students will not be announced at the trial. Schools will be notified.
- A DDPSSA Executive member will be present at all trials.
